## By car (coming from Vienna)



## Estimated travel time: approximately 2 hours

- 1. Take the A23 to the Knoten Inzersdorf junction and then continue on the A2. Follow the A2 for approximately 56 km towards Graz.
- 2. Take the inside right-hand lane at the Knoten Seebenstein junction to join the S6/Semmering expressway. Stay on the S6/B306 for approximately 94 km.
- 3. At the Leoben Ost junction, leave the motorway keeping to the inside right-hand lane of the S6 and continue on the Kärntner Straße (B116) direction Leoben Ost/Zentrum for approximately 2.4 km.
- 4. Keep right to Muehltalerstraße.
- 5. Toward Langgasse. The underground parking lot is on the left hand.

## By train

There are trains to and from Leoben at regular intervals. The journey from Leoben station to the Congress Leoben is approximately 5 minutes by taxi. There is also a public bus service.
